PLEASE BE ADVISED OF THE FOLLOWING ADDS/DELETES/CHANGES WHICH SHALL BE CONSIDERED AS INCLUDED IN THE ORIGINAL SPECIFICATIONS AND SHALL TAKE PRECEDENCE OVER ANY PART OF THE ORIGINAL SPECIFICATIONS IN CONFLICT THEREWITH.

IN THE SPECIFICATIONS

- ADD 1-1:** In the INSTRUCTIONS TO BIDDERS front-end document, under the Section titled "Completion Time": CHANGE the text (**90**) in the first sentence to (**365**). The remainder of this Section remains unchanged. For clarification, the Contract Time is changed from 90 calendar days to 365 calendar days.
- ADD 1-2:** In the CONTRACT BETWEEN OWNER AND CONTRACTOR AND PERFORMANCE AND PAYMENT BOND front-end document, under the Section titled "Time for Completion": CHANGE the text **Ninety (90)** in the first sentence to **Three Hundred Sixty-Five (365)**. The remainder of this Section remains unchanged. For clarification, the Contract Time is changed from 90 calendar days to 365 calendar days.
- ADD 1-3:** In PART II SPECIAL PROVISIONS, Section SP-3 BID ITEMS, CONTRACT DATES, AND DELIVERABLES, last line of the table with Milestone titled "End of Contract Time": CHANGE the "Date Due" (third column) from "180 calendar days after Notice to Proceed" to "365 calendar days after Notice to Proceed." The remainder of this Section remains unchanged.
- ADD 1-4:** In PART II SPECIAL PROVISIONS: DELETE Section SP-13 FLOOD SIDE 404C WETLANDS BOUNDARY in its entirety.
