All items are to be printed on a consistent paper stock of Premium 70# uncoated opaque stock (Cougar or similar) to be approved prior to printing. All bids must include expected turn-around time from date finished artwork is received.

Each bidder is to provide a detailed price quote detailing the services and materials to be provided on the attached bid sheet. SLFPA-W may ask for additional information prior to bid award.

This bid shall consist of all items contained on attached bid sheet.

It is expected that the work provided by the successful bidder will be professionally completed and ready to perform its intended function. Failure to provide such services or excessive delays may result in termination of this contract.

This is a non-exclusive contract. The contract will be valid for a period of one (1) year beginning September 1, 2009, through August 31, 2010.
