The SLFPA – W Board of Commissioners met at approximately 5:32 PM on Tuesday, December 1, 2015 at Our Lady of Holy Cross College – Moreau Center, 4123 Woodland Drive, New Orleans, LA 70131.

## **RESOLUTION NO. 120115-01**

A resolution providing for canvassing the returns and declaring the result of the special election held in the Algiers Levee District, on Saturday, November 21, 2015, to authorize the extension and rededication of a special tax therein.

BE IT RESOLVED by the Board of Commissioners of the Southeast Louisiana Flood Protection Authority - West (the "Governing Authority"), acting as the governing authority of the Algiers Levee District (the "District"), that:

SECTION 1. <u>Canvass.</u> This Governing Authority does now proceed in open public session to examine the official tabulations of votes cast at the special election held in the District on SATURDAY, NOVEMBER 21, 2015, to authorize the extension and rededication of a special tax therein, and said Governing Authority does further proceed to examine and canvass the returns and declare the result of the special election.

SECTION 2. <u>Procès Verbal.</u> A *Procès Verbal* of the canvass of the returns of said election shall be made and a certified copy thereof shall be forwarded to the Secretary of State, Baton Rouge, Louisiana, who shall record the same in his office; another certified copy thereof shall be forwarded to the Clerk of Court and *Ex-Officio* Recorder of Mortgages in and for the Parish of Orleans, who shall record the same in the Mortgage Records of said Parish; and another copy thereof shall be retained in the archives of this Governing Authority.

SECTION 3. <u>Promulgation of Election Result.</u> The result of said election shall be promulgated by publication in the manner provided by law.

PROCÈS VERBAL AND PROCLAMATION OF THE CANVASS OF THE VOTES CAST AT THE SPECIAL ELECTION HELD IN THE ALGIERS LEVEE DISTRICT, ON SATURDAY, NOVEMBER 21, 2015.

BE IT KNOWN AND REMEMBERED that on Tuesday, December 1, 2015, at 5:30 p.m., the Algiers Levee District, at its regular meeting place, the Moreau Center of the Our Lady of Holy Cross College, located at 4123 Woodland Drive, New Orleans, Louisiana, the Board of Commissioners of the Southeast Louisiana Flood Protection Authority - West (the "Governing Authority"), acting as the governing authority of the Algiers Levee District (the "District"), and being the authority ordering the special election held therein on Saturday, November 21, 2015, with the following members present:

Ms. Susan H. Maclay, Mr. Jim Wilkinson, Mr. Edward L. Camnetar, Mr. Paul R. Dauphin, Mr. Kendall Gaddy, and Mr. Michael L. Merritt;

Mr. Kerwin E. Julien, Sr. was absent;

did, in open and public session, examine the official certified tabulations of votes cast at the said election, and did examine and canvass the returns of the said election, there having been submitted at said election the following proposition, to wit:

## PROPOSITION (MILLAGE)

Shall the Algiers Levee District (the "District") be authorized to levy and collect annually a special tax of 6.35 mills on all property subject to taxation in said District (the "Tax") (an estimated \$1,224,000 reasonably expected at the time to be collected for an entire year) for a period of thirty years beginning with the year 2016, and ending with the year 2045, said Tax to represent a twenty-eight hundredths (0.28) mills increase over the 6.07 mills authorized to be levied through the year 2015 pursuant to an election held on November 19, 1983; and shall the revenues or proceeds of 6.35 mills of the Tax hereafter received from the authorization of the Tax be dedicated and used for the purpose of constructing and maintaining levees, levee drainage, flood protection, hurricane flood protection and for all other purposes incidental thereto, including payments required in connection with debt obligations incurred for any of the above described capital purposes, as well as a portion of the operation and maintenance of the Gulf Intracoastal Waterway - West Closure Complex, which is part of Louisiana's comprehensive integrated coastal protection plan and from which the jurisdiction of the Algiers Levee District derives benefit?

There was found by said count and canvass that the following votes had been cast at the said special election IN FAVOR OF and AGAINST, respectively, the proposition as hereinabove set forth at the following polling places, to-wit:
