## SOUTHEAST LOUISIANA FLOOD PROTECTION AUTHORITY – WEST (SLFPA – W) Technical, Operations and Maintenance Committee Meeting Wednesday, November 16, 2016

The Technical, Operations and Maintenance (TOM) Committee of the SLFPA-W met on Wednesday, November 16, 2016 with the following members present: Mr. Gaddy, chairman, Mr. Julien and Mr. Wilkinson.
