- ADD 1-4: What is the Project Budget? <u>RESPONSE:</u> The Engineer's Estimate will be announced at the Bid Opening. Bid Results from other projects are posted on the SLFPA-W website for bidders' information.
- ADD 1-5: Where is fertilizer specified? <u>RESPONSE:</u> The last section of the Technical Specs: "Section 32 92 19.04 12 Turf Establishment and Maintenance", discusses fertilizer.
- ADD 1-6: Is Ames Blvd. a truck route? There is a "no left turn" sign at Lapalco and the Uturn may be dangerous. <u>RESPONSE</u>: We believe the available routes to be adequate as they exist, but will follow up by Addendum if a change is necessary.
