### IN THE SPECIFICATIONS

ADD 2-1: In Specification Section 31 24 00.00 12 Embankment, Paragraph 3.6.1 "Additional Fill," in the second sentence: CHANGE the text from "...not to exceed 100 feet..." to "...not to exceed 300 feet...". Reference Item ADD 2-4 below for additional information.

## IN THE DRAWINGS

ADD 2-2: DELETE Sheet 5 of the Project Plans in its entirety and REPLACE with the attached Sheet 5 (REV 1, 4/30/18) attached hereto. The location of Staging Area 1 has been slightly modified, due to a conflict with the staging area for the 14c.2 project, which will be constructed concurrently.

# **QUESTIONS SUBMITTED IN WRITING**

ADD 2-3: "On the Agenda, it says that the attestations affidavit is to be submit for bid acceptance. In Article 7.1.3 of the specs it states that it should be submitted within 10 days after bid opening. Which one should be followed?" <u>RESPONSE:</u> The affidavit is for the successful bidder and due within 10 days of opening, it is not necessary for bid submission. It was only pointed out at the pre bid to make sure everyone remembered.

ADD 2-4: "Contract Section 31 24 00.00 (Embankment), Paragraph 3.6.1 requires settlement plates (if used) to be placed at intervals not to exceed 100 feet. Typically the maximum spacing of settlement plates is 300 feet. Would you consider allowing the

spacing of settlement plates to be between 100 feet and 300 feet?" <u>RESPONSE</u>: Yes; refer to the "Settlement Gage Detail" on Sheet 7 of the Project Plans for information on ranges and distances between settlement gages. The Specification section has been corrected herein accordingly (reference Item ADD 2-1 above).

ADD 2-5: "Will the Contractor be required to pay prevailing wages on this project?" <u>RESPONSE</u>: Yes. Refer to Specifications Part I <u>General Provisions</u>, Section GP-4 "LAWS, REGULATIONS, STANDARDS, SPECIFICATIONS, AND CODES."
