- e. Motion by Mr. Gaddy to authorize the administration to purchase professional liability insurance coverage with Indian Harbor Insurance Co. for the Southeast Louisiana Flood Protection Authority West, West Jefferson Levee District and Algiers Levee District, for the period from July 1, 2019 to July 1, 2020, in the amount of \$19,537.75, and to amend the budget accordingly.
- f. Motion by Mr. Gaddy to authorize the administration to purchase umbrella liability insurance coverage with Lloyd's of London for the Southeast Louisiana Flood Protection Authority West, West Jefferson Levee District and Algiers Levee District, for the period from July 1, 2019 to July 1, 2020, in the amount of \$61,075.13.
- g. Motion by Mr. Gaddy to authorize the administration to purchase worker's compensation insurance coverage with LUBA Casualty Insurance Company for the Southeast Louisiana Flood Protection Authority – West, West Jefferson Levee District and Algiers Levee District, for the period from July 1, 2019 to July 1, 2020, in the amount of \$47,103.00.
- h. Motion by Mr. Gaddy to authorize the administration to purchase contractors pollution liability coverage with Westchester Surplus Lines Insurance Company for the Southeast Louisiana Flood Protection Authority – West, West Jefferson Levee District and Algiers Levee District, for the period from July 1, 2019 to July 1, 2020, in the amount of \$10,434.67, and to amend the budget accordingly.
- i. Motion by Mr. Gaddy to amend the Budget for the fiscal year ending June 30, 2019, as follows:
  - i. Decrease "Interest Income" from \$250,000. to \$233,000.
  - ii. Decrease "Miscellaneous Income" from \$10,000. to \$1,500.
  - iii. Increase "Revenue Sharing" from \$472,746. to \$799,531.
  - iv. Increase "Permit Fees" from \$30,000. to \$50,000.
  - v. Increase "Sale of Equipment" from \$30,000. to \$74,000.
  - vi. Increase "Interest Income WJLD Capital Project" from \$0 to \$65,000.
  - vii. Increase "Interest Income ALD Capital Project" from \$0 to \$43,000.
  - viii. Increase "Sale of Property ALD" from \$0 to \$182,725.
