### IN THE SPECIFICATIONS

ADD 1-1: In <u>Part II - Special Provisions</u> of the Project Specifications, Section SP-10 SITE ACCESS: DELETE the first paragraph in its entirety and REPLACE with the following paragraph:

The project is accessible via Patterson Road, which runs parallel to the Mississippi River Levee. Both ends of the project site are accessible via General Meyer Ave. (Hwy. 428). The Contractor shall be responsible for staging area for equipment. Ferry operations shall not be disrupted.

### ITEMS DISCUSSED AT THE MANDATORY PRE-BID MEETING OF 8/26/2020

- ADD 1-2: This project is a cooperative endeavor between SLFPA-W and the City of New Orleans. SLFPA-W has coordinated with the City regarding Contractor access to the levee. The attached e-mail was distributed at the Pre-Bid Meeting for bidders' information.
- ADD 1-3: Question: Silt fence details are not provided; is a standard 36" high silt fence acceptable? <u>Response</u>: Yes.

ADDENDUM NO. 1 Page 1 of 2

- ADD 1-4: Question: Which existing levee ramps are accessible for construction? <u>Response</u>: All ramps within the project limits may be used by the contractor, except those that have been abandoned and are overgrown.
- ADD 1-5: Question: The typical section shows one foot of sod; is a 16-inch sod roll acceptable? <u>Response</u>: Yes, but the pay quantity will not change; it is based on a nominal one-foot width.
- ADD 1-6: Question: The DOTD Sod requirements are detailed pertaining to certain requirements like watering and establishment; will all these specifications be required? <u>Response</u>: SLFPA-W will be flexible on certain items within the DOTD Specification.
- ADD 1-7: SLFPA-W is currently performing surface prep on the levee crown, and will continue to do so prior to construction starting. It is not expected that much levelling of the base course surfacing material will be required by the Construction Contractor. This item is included in the bid as a contingency if needed.
- ADD 1-8: SLFPA-W will provide the Engineer's Estimate of Probable Construction Cost prior to opening bids.

#### **QUESTIONS SUBMITTED IN WRITING**

ADD 1-9: Question: Is the intention of the clearing and grubbing item to cut the grass? <a href="Response">Response</a>: The clearing and grubbing item will be used to prepare the surface for the work included in the project. Refer to Project Specification Sections SP-2 of the Special Provisions and 3.1 of Section 31 11 00.00 12. The Contractor is responsible for familiarizing himself with the site and conditions to determine what will be required.
