The Technical, Operations and Maintenance (TOM) Committee of the SLFPA-W met on Tuesday, September 8, 2020, with the following members present in person: Mr. Robinson; and by teleconference: Mr. Julien, Chairman. Mr. Thomas was absent.

The TOM teleconference meeting was called to order 1:35 P.M.

It was moved by Mr. Robinson and seconded by Mr. Julien to approve the agenda as presented.

There were no public comments.

It was moved by Mr. Robinson and seconded by Mr. Julien to approve the minutes from the previous meeting, dated August 11, 2020.

Mr. Bergeron provided an update on incidents and safety matters. The Committee will continue to be updated on incidents and safety matters.

Mr. Cali provided an update on the lifts and armoring status. There were no issues.

Mr. Cali provided an update regarding the West Closure Complex (WCC) operations and maintenance (O&M) status. There were no issues.
