The Technical, Operations and Maintenance (TOM) Committee of the SLFPA-W met Tuesday, March 9, 2021, with the following members present in person: Mr. Robinson; and by teleconference: Mr. Julien, Chairman and Mr. Thomas.

Mr. Julien called the meeting/teleconference to order in the SLFPA-W Office Board Room, 7001 River Road, Marrero, Louisiana at approximately 1:30 P.M.

It was moved by Mr. Thomas and seconded by Mr. Robinson to approve the agenda as presented.

There were no public comments.

It was moved by Mr. Robinson and seconded by Mr. Julien to approve the minutes from the previous meeting, dated February 9, 2021.
